### **LACOE Sounds Alarm on BHUSD Budget**

In its review of the Board of Education's 2017-2018 Second Interim Report, the Los Angeles County Superintendent of Schools (LACOE) expressed several concerns regarding deficit spending.

LACOE pointed out in a letter to the Board, dated April 10, that the district projects an operating deficit of \$2.8 million, representing 5.4 percent of the combined unrestricted General and Special Reserve Funds projected expenditures and other outgo for fiscal year 2017-18.

The district also projects operating deficits of \$4.1 million for 2018-19 and 2019-20. This essentially means that over a three-year span, the combined unrestricted General and Special Reserve Funds' ending balance will likely decrease 78 percent, from \$15.8 million to \$3.4 million.

'We are concerned that if this deficit spending trend continues as projected, it will jeopardize the district's fiscal solvency in 2021-21 and beyond," said the letter.

The Board chose not to pursue reconfiguration this year, which would have saved up to \$4 million per year.

Although the BHUSD staff report emphasized that LACOE did concur with the district's positive certification, it failed to mention that the County requested a fiscal stabilization plan (FSP) be submitted with its 2018-19 Adopted Budget, along with a board resolution plan on July 2.

LACOE also requested that the Board provide updates to the County regarding the Karen Christiansen construction management litigation award as they become available.

The California Supreme Court conducted an appeal hearing on February 14 and a decision is pending.

# Will There Be "Infiltration **Galleries**" Underneath La **Cienega Park?**

Nguyen, La Cienega Park and the Frank Fenton Field were identified as the locations for one of the signature regional projects for the Ballona Creek Watershed because it has tributary areas to three cities: Beverly Hills, West Hollywood and Los Angeles.

"So, in theory, if we do any projects here, it would be a joint effort [between] the three cities, hence a regional effort project," said Nguyen, adding that the large open space of the two parks also provides an ideal project space.

The purpose of what Nguyen referred to as an "ambitious project" is to determine the viability of building underground infiltration galleries beneath the project sites. Eight feet in diameter, these large perforated pipes would allow water to percolate down into the ground.

"That was one of the main components of the project-to essentially recharge the groundwater basin with stormwater that we capture, treat and then recharge," said Nguyen.

The City is a co-permittee of the 2012 Municipal Separate Storm Sewer System Permit-issued to enforce the requirements of the Federal Clean Water Act by regulating discharges of pollutants into the water.

Along with Culver City, Inglewood, Los Angeles, Santa Monica and West Hollywood, Beverly Hills discharges runoff from the Ballona Creek Watershed into various bodies of water.

As a solution, the City and several agencies developed the Enhanced Watershed Management Program (EWMP) to meet the requirements of the MS4 permit. It was approved on April 20, 2016.

In October, 2017, the City Council awarded an agreement with Black and Veatch Corporation to provide engineering services to assess the feasibility for the design and implementation of the project.

The geotechnical and hydrogeological investigations Nguyen said, essentially worked to determine whether the soils were capable of percolating. They also reviewed the LA County Guidelines for Stormwater Infiltration & Groundwater Recharge.

Through these studies and research, Black & Veatch discovered that soil 8-32 feet deep is susceptible to liquefaction.

This posed an issue with for the County, which doesn't want projects to induce liquefaction as it could bring "instability" to the surrounding areas.

Nguyen also said that the percolation rate was "very low" at .01 inch per hour. The minimum County requirement is .3 inches per hour.

"From those investigations, infiltration and recharge is not practical to the extent that we've analyzed," said Nguyen.

But what about remaining options?

Nguyen said because there isn't a way to infiltrate the water underneath the ground, they must find ways to get rid of it. Staff is looking at harvesting and directly using the water, diverting it to the sanitary sewer system, discharging it back into the MS4, or some combination of the three.

At a recent meeting with Los Angeles and West Hollywood, the collective recommendation was diverting the capture-able water to the sanitary sewers. This means that most of the water would be able to be reused, unlike with the other two options.

Next steps include further assessing the technical merits of capturing and discharging weather flows into the sanitary sewer system, and developing project engineering costs estimates.

The three cities are scheduled to proportionately share any costs born by the project.

### **Mirisch Speaks Out Against SB 827**

Vice Mayor John Mirisch flew to Sacramento on Thursday to speak out against Senator Scott Wiener's (D-San Francisco) proposed Bill 827 at the Senate Transportation and Housing Committee.

The bill, which has garnered significant opposition across the state, was killed in committee.

"It's time we finally recognize that the value of our individual communities is one of the things that makes California great," said Mirisch. "It's time we finally stop trying to pass one-size-fits-all laws which treat people like widgets."

SB 827 would have allowed developers the right to build four to five stories within a half-mile of a major transit stop or transit corridor, effectively invalidating many local zoning ordinances.

The Beverly Hills City Council unanimously passed a resolution opposing the bill several months ago, contending that the result would "clearly be a spike in average rents in Beverly Hills and a net loss of affordable units."

Although it is packaged as a "transit-rich" bill, some have argued that this is not the case.

"SB 827 isn't a housing or transit bill; SB 827 is a real estate bill, which turns transit into a sales amenity," said Mirisch. "That's just one reason why SB 827 represents one of the largest wealth transfers from the public to the private sector in state history."

But the bill's supporters maintained that current environmental review procedures and local controls make new develop-



ments in many areas nearly impossible. "The status quo isn't working and we need to do things differently," said Wiener. "We need an enormous amount of new housing at all income levels."

In the committee's vote, the bill lost four to seven.

# Smith Criticizes Board's "Inefficiency"

Beverly Hills Education Association (BHEA) President-Elect Ethan Smith spoke at length about the Board of Education's lack of efficiency regarding the future of reconfiguration and salary formula at Tuesday's

meeting.

Smith's speech, which earned a rousing applause from the audicriticized ence. Board for the appointing the 21-member Future Focused Schools Team (FFST) only subsequently to ignore the group's recommendation of implementing a dedicated middle

school. The FFST spent over four months researching viable options to address the district's unsustainable financial path of maintaining four K-8's, ultimately presenting their findings to the Board earlier this year.

The Board responded by taking steps to pass a bond and assemble another committee to conduct further research regarding reconfiguration.

"That's inefficient," said Smith. "But then to debate at the last meeting Board meeting for an hour whether or not to form yet another reconfiguration committee to give you the same information yet again? That's super inefficient."

An FFST member himself, Smith also went on to express his disapproval of the impasse the district is currently at with BHEA.

The BHUSD offered a three percent salary increase (nine percent total) for the next three schools years. And while the BHEA has asked for a six percent salary increase (18 percent total) over the same period of time, the organization ultimately desires to leave the salary formula as is.

"If our district was efficient the salary formula wouldn't even be an issue," said Smith, noting that comparable cities like Culver City have raised teacher salaries and contributed more money than Beverly Hills to teacher health benefits despite receiving less revenue per student each year. "How do they do this? Efficiency. The salary formula is efficient. LACOE is efficient. Going to impasse is not."

# Council Discusses Basement Referendum Petition

The City Council discussed on Tuesday a referendum petition calling for the repeal of the Basement Ordinance.

They discussed the viability of an ordinance that would require signature gatherers for local ballot measure petitions to wear badges indicating whether they are volunteer or paid and whether the alleged violations of state law prohibiting petition circulators from making false and misleading statements should disqualify a measure from appearing on the ballot.

The discussion stems from the Coun-

cil's received reports alleging that circulators of the referendum petition made "false statements" regarding the effect of the Ordinance in an effort to induce residents to sign the petition.

"The tactics used for the direct attack on the Basement Ordinance by the Referendum are not a Hillside problem, it is a Beverly Hills problem," wrote Lago Vista resident Debbie Weiss in a letter to the Council. "The tactics used by those looking to exploit our codes and laws have reached a breaking point."

The code Weiss is referring to is Elections Code 18600, which says it is a misdemeanor to "intentionally misrepresent or intentionally make any false statement concerning the contents, purport or effect of the petition to any person who signs [a petition."

Weiss suggests that petitioners have "tricked" residents into signing the ordinance, writing that many later expressed remorse for signing the petition without fully understanding what exactly they signed.

risters is the BHBA division that serves lawyers under 37 years of age or who have been practicing less than ten years. The current Roxbury Park Legal Clinic Chair is Jonah Grossbardt.

Bradford, who joined the BHBA in 1991, said that the genesis of the Roxbury Park Legal Clinic stemmed from wanting to provide access to legal services for underserved groups.

# Apartment Association of Greater Los Angeles Executive Director Dan Yukelson on fighting the Rent Stabilization Ordinance By Olivia Anderson

# How'd you first get involved in city government?

Way back in the beginning of my career, [I was] a treasurer for a school board campaign for a guy named Michael Karlin. By doing that I got some expertise on how to fill out all the campaign statements and how to run a campaign. Slowly but surely, [Karlin] recommended me to Allan Alexander and I worked on a couple of [his] City Council campaigns. More and more people got the word that I knew how to be a campaign treasurer, so that's how I got involved. I actually worked as a campaign treasurer for [former Mayor] Tom Levyn, started the Team Beverly Hills program in the City, and starting the third year of that program I joined Team Beverly Hills. I waited a few years but eventually applied to become a Public Works Commissioner, and that's really how I got involved on the commission route.

# Tell us about your past experience on the Planning Commission.

I was a Public Works Commissioner for two and a half years, and then openings came up on the Planning Commission. I applied and was one of three people selected to go on the Planning Commission. I went on with Lili Bosse and Nan Cole. I was the third selection, I waited out for nine months, went to all the meetings, and served as a Public Works Commissioner during that time. Then I eventually [served] on the Planning Commission for six years.

I really enjoyed it. It was very challenging because I had a very busy career. I was the Chief Financial Officer of the largest radio network in the United States called Premiere Radio Network. So, it was a challenge to fit the 30-40 hours a month I needed to be a Planning Commissioner into my schedule. But I did enjoy it, and felt I was serving the needs of our City and making a positive impact.

#### What were some of the major issues on the Planning Commission at that time?

One of the big issues that I struggled with a lot was the Gateway project redeveloping the City strips of railroad land that go along South Santa Monica Boulevard. I tried my hardest to get it passed; I did get it through the Planning Commission. I wanted to do it while I was chair but there was some delay so it went over to the next chair, which was Craig Corman. We actually did get it passed on the Planning Commission and recommended that the City Council [approve it] but unfortunately the City Council looked at it in an election year and just did not want to struggle with a project that they deemed to be controversial. But now, every time I drive by there I think that we'll have to look at those conditions on South Santa Monica Boulevard in the next 30-40 years until somebody else is able to come along with a decent project to improve that area. I've always felt that area does not look like Beverly Hills.

How did you get involved in fighting the Rent Stabilization Ordinance?

About four years ago, my wife and I decided to sell our single-family home. We had a house on South Roxbury Drive that we lived in for about 13 years. Our daughters had grown up and moved out

of the house for college, and my wife and I decided that we wanted to downsize. We made a decision to buy a fourunit apartment building in Beverly Hills on Olympic Boulevard, where we could live in one of the units and then have some of our housing costs subsidized by our rent income. Not long after I purchased this building came the emergency Rent Stabilization Ordinance (RSO).

Because I bought recently, I ended up having a much higher property tax base. My costs are a lot higher, the building is over 80 years old, and not only did I pay a pretty high price for the building; I also put in significant upgrades—almost half a million dollars in upgrades for the building to improve it. Right after doing that, the RSO passed. Had I known this was coming, I might not have made this decision to sell my house and buy a rental property in Beverly Hills. The numbers just don't pencil out for me anymore. I'm very concerned because the costs of operating an 80-year-old building are very expensive. Plus property taxes go up two percent a year and we have a bond the school board wants to pass and the cost earthquake insurance is skyrocketing—

it's almost impossible for me to meet the financial criteria I originally went into buying the building with.

I was upset. The audacity of the City Council wanting to protect tenants that can afford to pay \$10,000 a month—who are we protecting in our city? It's just ridiculous. It was so poorly thoughtout, and it was an obvious political move. You have socialists on the Council who not only believe in rent control but also this ballot initiative that has been proposed which

would basically bankrupt all these Momand-Pop owners of rental properties in Beverly Hills. I'm a small owner; I don't have a big balance sheet like some of these financial firms. I've invested in my neighborhood. I live in my neighborhood. If people want [to pass this initiative], you're just going to get big Wall Street firms coming in, scooping up these buildings, knocking them down, building housing. You're going to get owners who just don't care about Beverly Hills.

You can't operate a business without any flexibility to increase your prices. Being capped at three percent makes it even more challenging. Plus, with a building like I have to run, it's nearly impossible. I'll be in the red more often than not.

#### So, then the Apartment Owners of Greater Los Angeles hired you as an executive director, correct?

Yeah. I was galvanized by the rent control issue, because I just think it's ridiculous and it's hurting me financially. They had an opening here for an executive director and I was at the point where I was ready for a second career. I decided to take it and run a nonprofit organization. I had been a finance guy at numerous public, private and startup companies for over 30 years, and I just felt like a change. I thought this would be a lot of fun.

#### The City is spending over \$130,000 on an RSO study. What do you make of this?

It's crazy. I don't think they really know what they're looking for. They're kind of shooting in the dark, hiring a socalled expert. \$130,000 is just a drop in a bucket compared to the proposed \$1.4 million a year the City wants to spend in managing and administering this RSO. They haven't even factored in the fact that they're probably going to get sued more often than not. The City doesn't really know what it's up against in terms of the amount it's going to cost them every year and it's really a shame. Tell us about your plan to fight the RSO. What, in your opinion, is a viable alternative?

We have organized a group of property owners in the City and we've raised

a decent amount of money. Any candidate that runs in the City from now on will have an uphill battle because we're putting in a lot of money. We have a real estate database called CoStar. It surveys the rents all throughout the country and we took a look and did a study on rents in Beverly Hills. Rent increases in Beverly Hills since 2014 trails increases in surrounding neighborhood. Why? Well, the surrounding neighborhoods all have rent control already. It's been proven all over again that rent control only increases rents higher than people expect because property owners need to make up the cost of operating their buildings. When tenants move out, they need to jack up the rents much higher.

In looking at Beverly Hills, rent increases for studios and one-bedrooms were approximately 2.3 percent of a year. Once the RSO passed, they shot up to 2.9 percent. The only instance of double-digit rent increases that these rent control zealots like [renter activist] Mark Elliot keep spewing out were in luxury buildings like the 4 and 5 star buildings, and there aren't a lot of them in Beverly Hills. Rent increases were over 10 percent but the minute the RSO passed, they dropped down to three percent. So, the City is actually protecting wealthier tenants.

I'm totally for helping people that need it; I just think the City spending \$1.4 million to benefit everybody, even people who don't need it—Elliot is some type of tech executive. I wish I could afford the type of bikes he rides on weekends. Why not try to get something as cheap as he can? If the City really wants to help people, they could take that \$1.4 million they want to spend every year and come up with some kind of voucher system based on actual need. If you're elderly or disabled on a fixed income, or for whatever reason can't afford to pay your rent, you should go to the City, apply for it, and the City should help subsidize you. Why take it out of my pocket?
